

## Personal Conduct Guidelines

A prime objective of the JCGA is to promote a sense of the traditions and integrity for the game of golf. We expect all participants and their parents to conduct themselves in a manner that shows respect for fellow participants, themselves and the golf course. Therefore, the following guidelines will apply at all JCGA related activities.

I understand that the following will not be tolerated: Conduct detrimental to the JCGA, LPGA International and all participating facilities, including but not limited to: abuse of facilities; use of alcohol or illegal drugs; gambling; abusive language or profanity; displays of temper involving throwing or slamming of bags, balls, clubs or other equipment; cheating; poor golf etiquette; and breach of USGA Rules of Golf.

Any breach of the above guidelines on conduct will result in:

- 1st offense: Verbal warning
- 2nd offense: Written warning to parent
- 3rd offense: Suspension
- 4th offense: Dismissal for all junior programs

Any blatant or intentional violation of any guidelines resulting in personal injury or property damages will lead to automatic suspension from all programs.

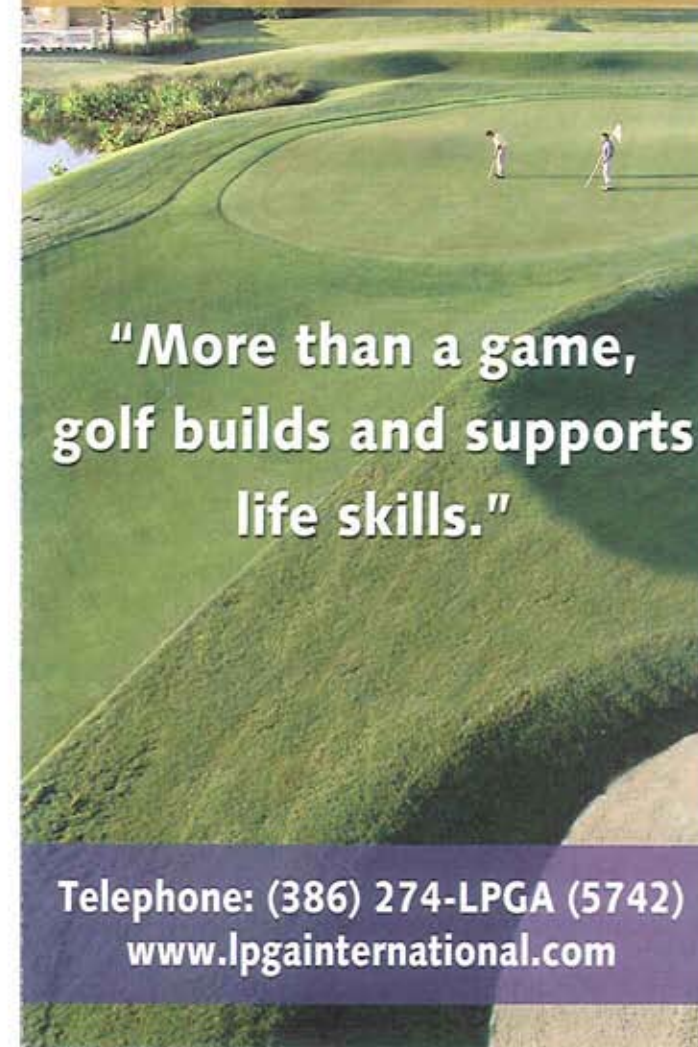
